Breda City Council Minutes June 20, 2022 City Hall

Mayor Dan Snyder call the special meeting to order at 5:32pm with Samantha Pietig, Justin Agan, Chris Uhlenkamp, and Kayla Tiefenthaler calling in. Absent was Bob Boeckman.

Resolution 2022-06-03 Approving Deed for Lot 9 in the Breda Third Addition to Jim Tiefenthaler Construction was considered. A motion to approve was made by Uhlenkamp and seconded by Agan. Roll Call vote was heard and Pietig, Tiefenthaler, Agan, and Uhlenkamp all voted Aye. Absent was Boeckman.

Council then discussed the current pool rules that were voted into place May of 2020 as seen below:

Breda Pool Rules

- Use pool at your own risk.
- Management assumes no responsibility for any injury, death, accident, or incident that may occur. All persons under the age of 18 are the responsibility of the parents or guardians.
- All children under the age of 10 must be accompanied by a responsible person over the age of 16 for admission to the facility.
- No child under the age of 6 or of limited swimming ability shall be allowed in the pool unless accompanied by a responsible person over the age of 16 and such person must be in the water along with the child.
- Please show respect for the facility, lifeguards, and staff and toward others using the facility.
- No running, pushing or other dangerous horseplay.
- Management reserves the right to deny use of pool to anyone at any time.
- Lifeguards will enforce a zero-tolerance policy for inappropriate or dangerous behavior and those not obeying the rules will be excused from the pool.
- No visiting with lifeguards while they are on duty. Only staff members are allowed in the guard shack.
- Flotation devices of any type are not allowed in the deep water.
- All children will be required to pass a swim test to be allowed in the deep end of the pool. Test will require the swimmer to swim across the deep end and back one time and tread water for one minute.
- Children will be required to wear a red, yellow or green wrist band. Children will be tested by guards and assigned the proper color wrist band.
- Non-breakable Water bottles are allowed. No food, alcoholic beverages, glass containers, smoking or horseplay is permitted in this facility. No pets are allowed.
- The use of photographic equipment to take pictures of any person in the pool is prohibited without consent.
- Please be watchful of your belongings. We are not responsible for lost or stolen items.
- Please report faulty or damaged equipment or issues to City Hall at 712/673-2660 immediately.

This Facility is under 24-hour electronic surveillance.

Call 911 for an emergency. Approved by the Breda City Council May 11, 2020
