BE IT ORDAINED BY THE CITY Council of the City of Breda, Iowa:

Section 1. Section Modified. Ordinance 5-4-9 Refuse Collection Rates are hereby repealed and the following adopted in lieu thereof.

5-4-9. Rates for Refuse Collection. For each resident with alley or curb pickup, \$16.73 for on garbage or rubbish collection each week. In the event that the alley or curb for any residence is not feasible, the City Clerk is hereby empowered to enter into an agreement with such resident for any additional charge to be paid by such resident for any other location of pickup that may be agreed upon.

Section 2. Severability Clause. If any section, provisions or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

Section 3. Effective Date. The ordinance shall be in full force and effect upon publication or written notification as required by the Code of Iowa.

Section 1. Section Modified. Ordinance 5-4-8 Water Rates are hereby repealed and the following adopted in lieu thereof.

5-4-8. Rates for Service. Water service shall be furnished at the following monthly rates within the City: (Code of Iowa, Sec. 284.84)

Metered Gallons \$30.00 minimum plus charge per gallon

Landscape meters Must pay for the meter. No minimum meter fee and then pay for gallons

used at the same rate of the main water meter.

All additional gallons- \$9.92 per 1000 gallons

The minimum charge shall be billed per water connection per billing month.
